Subject:

Closing of subscription of bonds series 6 for the benefit of the Covid-19 Response Fund with total nominal value of 500,000,000 EUR issued under the EMTN programme

Content of the report:

Due to the closing of subscription for series 6 bonds issued under the Euro Medium Term Note Programme of up to EUR 15,000,000,000 (the "EMTN Programme") and the intention to introduce the bonds to trading on the regulated market in Luxembourg, Bank Gospodarstwa Krajowego with its registered office in Warsaw (the "Bank") hereby provides information on:

- 1) subscription opening and closing date: opening date: 1 July 2021, closing date: 1 July 2021,
- 2) securities allocation date: 1 July 2021,
- 3) the number of securities covered by the subscription: 5 000,
- 4) reduction rate in specific tranches, if at least in one of the tranches the number of allocated bonds was lower than the number of subscribed bonds: Eurobonds were to be issued in one tranche with a reduction rate of 15.6%,
- 5) the number of securities for which subscriptions were made: 5 926,
- 6) the number of securities which were allocated within the subscription: 5 000,
- 7) the subscription price of the securities: 98.965% of the principal amount,
- 8) the number of persons who subscribed the securities in specific tranches: 50,
- 9) the number of persons to whom the securities were allocated within the subscription in specific tranches: 50,
- 10) the name of underwriters who acquired the securities under an underwriting agreement, the number acquires securities; the actual price of one security being the issue price less the underwriting commission: N/A,
- 11) the aggregate principal amount of subscription, i.e. the product of number of securities under the offering and the issue price: 494,825,000 EUR (in words: four hundred ninety four million eight hundred twenty five thousand euros) which is equal to 2,235,965,727.50 PLN (in words: two billion two hundred thirty five million nine hundred sixty five thousand seven hundred twenty seven zloty 50/100) according to average NBP fixed rate as of 1 July 2021,
- 12) the total costs which were recognised as the issuance costs: the Bank will disclose such information in an updated current report after it has received and accepted all the invoices connected with the issuance,
- 13) the average cost of subscription per one security: the Bank will disclose such information in an updated current report after it has received and accepted all the invoices connected with the issuance,
- 14) the way of payment for securities to be acquired: the payment will be made by a wire transfer to the Bank's account.
